The minimum local content to qualify as a Class 1 local supplier is denoted in the bid document. If the bidder wants to avail themselves of the Purchase preference, the bidder must be the manufacturer / OEM of the offered product on GeM. 8. 9. ### 1. Generic

OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 25 percent of bid quantity at the time of placement of contract. The purchaser also reserves the right to increase the ordered quantity up to 25% of the contracted quantity during the currency of the contract at the contracted rates. The delivery period of quantity shall commence from the last date of original delivery order and in cases where option clause is exercised during the extended delivery period the additional time shall commence from the last date of extended delivery period. The additional delivery time shall be  $(\text{Increased quantity} \div \text{Original quantity}) \times \text{Original delivery period (in days)}$ , subject to minimum of 30 days. If the original delivery period is less than 30 days, the additional time equals the original delivery period. The Purchaser may extend this calculated delivery duration up to the original delivery period while exercising the option clause. Bidders must comply with these terms.

12. **Generic**

iii) The Seller fails to deliver the Material(s) or any part thereof within the stipulated Delivery Period and/or to replace/rectify any rejected or defective Material(s) promptly.

iv) The Seller becomes bankrupt or goes into liquidation.

v) The Seller makes a general assignment for the benefit of creditors.

vi) A receiver is appointed for any substantial property owned by the Seller.

vii) The Seller has misrepresented to Buyer, acting on which misrepresentation Buyer has placed the Purchase Order on the Seller.

Seller shall be required to ensure supply as per approved sample with modifications as communicated by Buyer. If there is delay from buyer side in approval of advance sample – the delivery period shall be refixed without LD for the period of delay in sample approval. In case, the sample is found to have major deviations / not conforming to the Contract specifications, the buyer at its discretion may call for fresh samples for approval before allowing bulk supplies or may terminate the contract after notifying the deviations to the seller.

Unless otherwise provided in the contract, all samples required for test shall be supplied by the contractor free of cost. Where under the contract, the contractor is required to submit an advance sample, any expenses incurred by the contractor on or in connection with the production of stores in bulk, before the sample has been approved unconditionally shall be borne by the Seller and he shall not claim any compensation in the event of such sample being found unacceptable by the Buyer / Consignee.

Depth Wardrobe Top- Is made up of 25mm thick Prelam (BSL) particle board confirming to IS 12823: 1990 with 2mm thick PVC lipping glued. Table top undergoes a distributed load test for deflection by applying 0.027kg/mm load on Top and concentric load test by applying 90kg load on weaker section.

Body-It consists of the bottom panel, LH and RH side panel, LH and RH shutter, shelf and bottom panel as a main part. LH and RH are made up of an 18mm thick BSL particle board confirming to IS 12823: 1990 with 0.8mm thick PVC lipping glued. Both the side panels have a depth of 573 mm. skirting and bottom panel are made up of 18mm thick BSL particle board confirming to IS 12823: 1990 with 0.8mm thick PVC lipping glued. Bottom panel and Skirting are connected with each other by a leveler bracket. Intermediate vertical panel is made up of an 18mm thick BSL particle board confirming to IS 12823: 1990 with 0.8mm thick PVC lipping glued, vertical panel having the provision holes for shelf adjustment.

Full Shelf of 723 mm width, Half Shelf of 352 mm width and the divider panels are made up of 18mm thick OSL particle board confirming to IS 12823: 1990 with 0.8mm thick PVC lipping glued. Shelf is having a depth of 533mm. SS oval shape hanger rod is screw on both the side panel, which is having a length of 854mm. The construction shall be aesthetically appealing and completely knock down connect with each other by using Minifix & Dowels.

Shutter - 4 Nos - The complete storage shall have two shutters of 18mm thick Prelam (BSL) particle board confirming to IS 12823: 1990 with 2mm thick PVC lipping glued and shutter is hung on with 0 Crank hinges on both the side panel. Aluminum handle is used in both the shutter of 160mm CD (center to center distance handle hole). Black color PVC door strip and multi-purpose square lock is used.

Drawer- Drawer body is made up of 18mm Prelam (BSL) particle board conforming to IS 12823:1990 and drawer base is made up of 9mm thick Prelam (BSL) particle board conforming to IS 12823:1990. Drawer fascia made up of 18mm thick Prelam (BSL) particle board confirming to IS 12823: 1990 with 2mm thick PVC lipping glued.

The Recess Handle is used as a handle and Drawer mounted on the bottom mounting slide. The product must be from a Manufacturer having ISO 9001,ISO 14001 certificates.

Timely Servicing / rectification of defects during warranty period: After having been notified of the defects / service requirement during warranty period, Seller has to complete the required Service / Rectification within 5 days time limit. If the Seller fails to complete service / rectification with defined time limit, a penalty of 0.5% of Unit Price of the product shall be charged as penalty for each week of delay from the seller.
