1. First Term Tuition fee includes caution deposit of Rs. 20,000/- and Alumni fee of Rs.10,000/-.
2. The caution deposit of Rs. 20,000/- is refundable at the time of leaving the institute subject to adjustments, if any.
3. The term wise amount indicated above is payable at the beginning of each term and late payment may invite payment of late fees and/or other penalties.
4. In addition to above fee, mess expenses will be payable @ Rs. 27,000/- per term plus GST amount of 5% (GST amount may change as per notification). No daily or meal wise payment is collected for mess expenses.
5. Refund of fee collected will be governed by Withdrawal Policy as enclosed below.

WITHDRAWAL POLICY

MBA, MBA-HRM & MBA-BA- Batch 2026-28

Any candidate who has been admitted to IIM Ranchi for its MBA/MBA-HRM/MBA-BA programme through JAP may withdraw his/her admission by logging in through the Admission Portal. Based on the date and time which the candidate withdraws, IIM Ranchi will calculate the applicable refund accordingly.

The refund of fees as applicable shall be made in due course and after deduction of the cancellation charges as shown in the table below:

2	Request received after the candidate registers for the programme and decides to leave <i>on</i> or <i>after</i> notified date of commencement of classes.	No Refund (except caution deposit and Alumni Fee)
3	Candidates who register for the programme <i>on</i> or <i>after</i> notified date of commencement of classes	No Refund (except caution deposit and Alumni Fee)

Important information to be reviewed and accepted by candidates:

- The date of commencement of classes will be published (notified) in the IIM Ranchi website at least 15 days before commencement of classes. As on date, classes are tentatively scheduled to commence on 15 June, 2026 (final date will be notified later on www.iimranchi.ac.in). Candidates who accept offers and register for the programme *on* or *after* notified date of commencement of classes will have no window of withdrawal without refund irrespective of whether the offer which was accepted, was made by IIM Ranchi before/on/after notified date of commencement of classes. Candidates accepting any offers after notified date of commencement of classes are deemed to have specifically accepted this condition limiting their withdrawal and refund possibilities.
- Payment of the fee for the first term by a candidate indicates that the candidate has accepted the offer and has chosen to register for the programme. If a candidate does not register for the programme through payment of the fee within the deadline as mentioned in the offer letter, it implies that candidate has withdrawn from the programme, and no further request for extension in the registration date will be entertained.
- For all candidates who withdraw on or after notified date of commencement of classes, please note the following:
 - To receive a refund of caution deposit and Alumni Fee, candidate has the sole responsibility to clear dues and submit no dues form duly signed by all the concerned departments. Cost of books, welcome kit etc. will be adjusted from caution deposit.
 - Mess charges will not be refunded.
- Candidates are solely responsible to ensure that they check their email (including spam folder) and the IIM Ranchi website at regular intervals to ensure that they receive updated information. Candidates must ensure that they keep their login information of the IIM Ranchi Admission portal confidential and they should not share it with anyone. Candidates will be solely liable for misuse of login information of the IIM Ranchi Admission portal.
- Any dispute will be subject to the jurisdiction of courts in Ranchi, Jharkhand only. IIM Ranchi reserves the right to modify or update the Withdrawal Policy at any time.
- The Withdrawal policy is binding on any candidate seeking admission to IIM Ranchi, and candidates are requested to closely read and understand the policy before accepting the offer and payment of fee. Candidates who have received an offer and pay the fee are deemed to have consented to this Withdrawal Policy.
- Candidates seeking to change their choices within full-time PGPs (i.e. between MBA/MBA-HRM/MBA-BA) before the notified date of commencement of classes based on receipt of offers will have to withdraw from the programme wherein they accepted the prior offer and then register against the new offer by seeking an adjustment of fee through the portal.
- Candidates seeking to change their choices within full-time PGPs (i.e. between MBA/MBA-HRM/MBA-BA) after the notified date of commencement of classes will not be eligible for refund against the fee paid for the programme from which they withdraw.
- Withdrawal request once made by a candidate cannot be rescinded by him/her, unless explicitly permitted by the Institute. The refund for candidates who withdraw from any of the programmes will be made within 60 days of the notified date of commencement of classes, as per this Withdrawal Policy.
- The admission of any candidate is provisional and subject to verification of documents and eligibility. If any incorrect information or inconsistency is discovered, it may be cancelled/terminated at any time.
